## **411.3 Kings Road Safety Improvements**

The City of Edinburgh Council (CEC) advised they are reviewing the Kings Road design scheme.

Option3, to make design improvements, Lothian Buses involved in the design review.

Preferred design to be decided by mid-April.

Lee Kindness commented - Lothian Buses have historically been part of the conversation.

Frustrating this is being dragged out.
